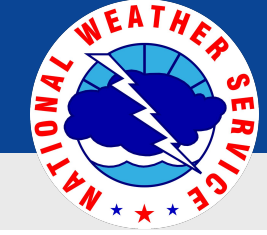

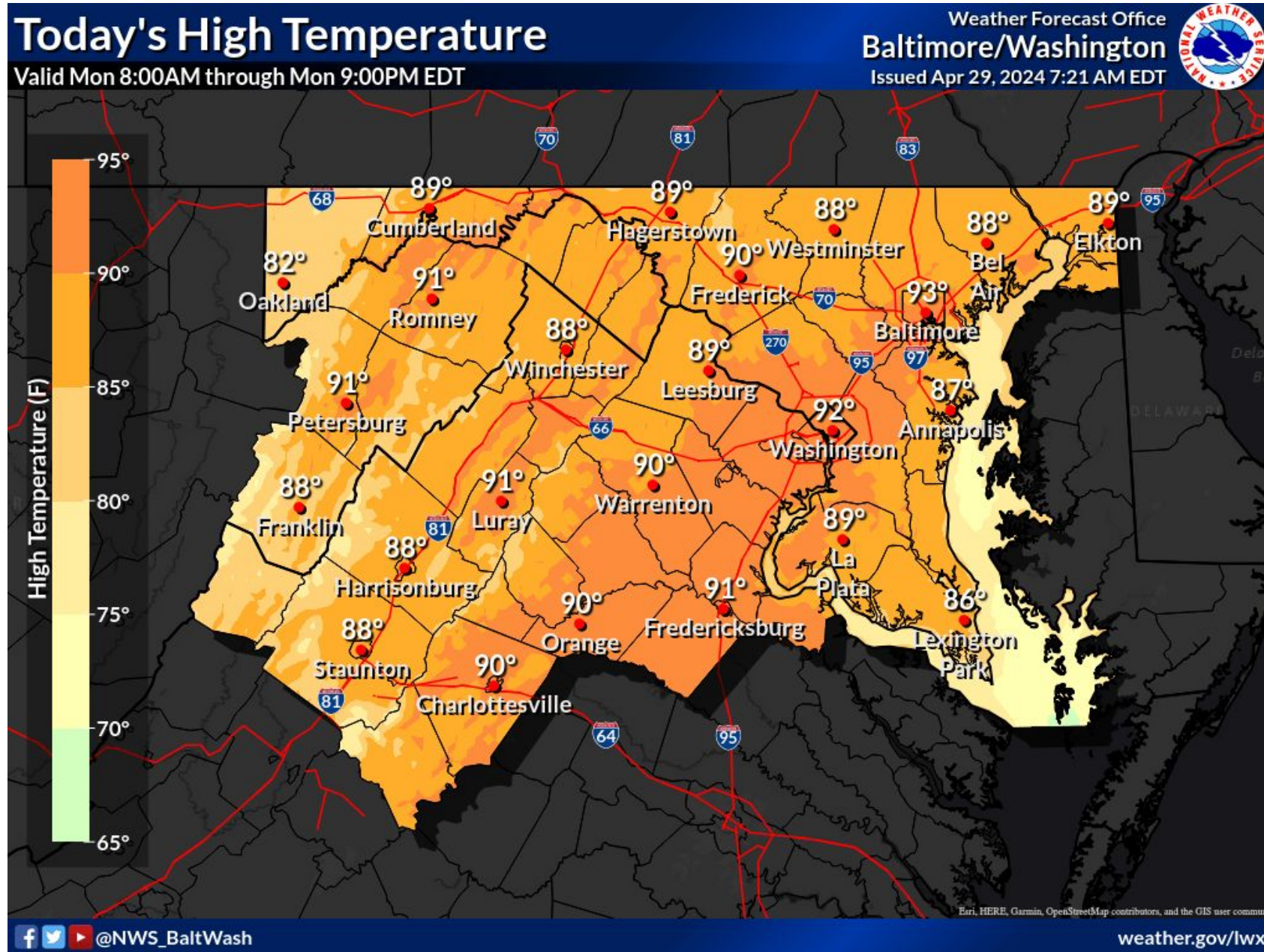

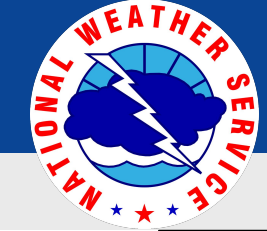

- Highs into the upper 80s and 90s for most areas.

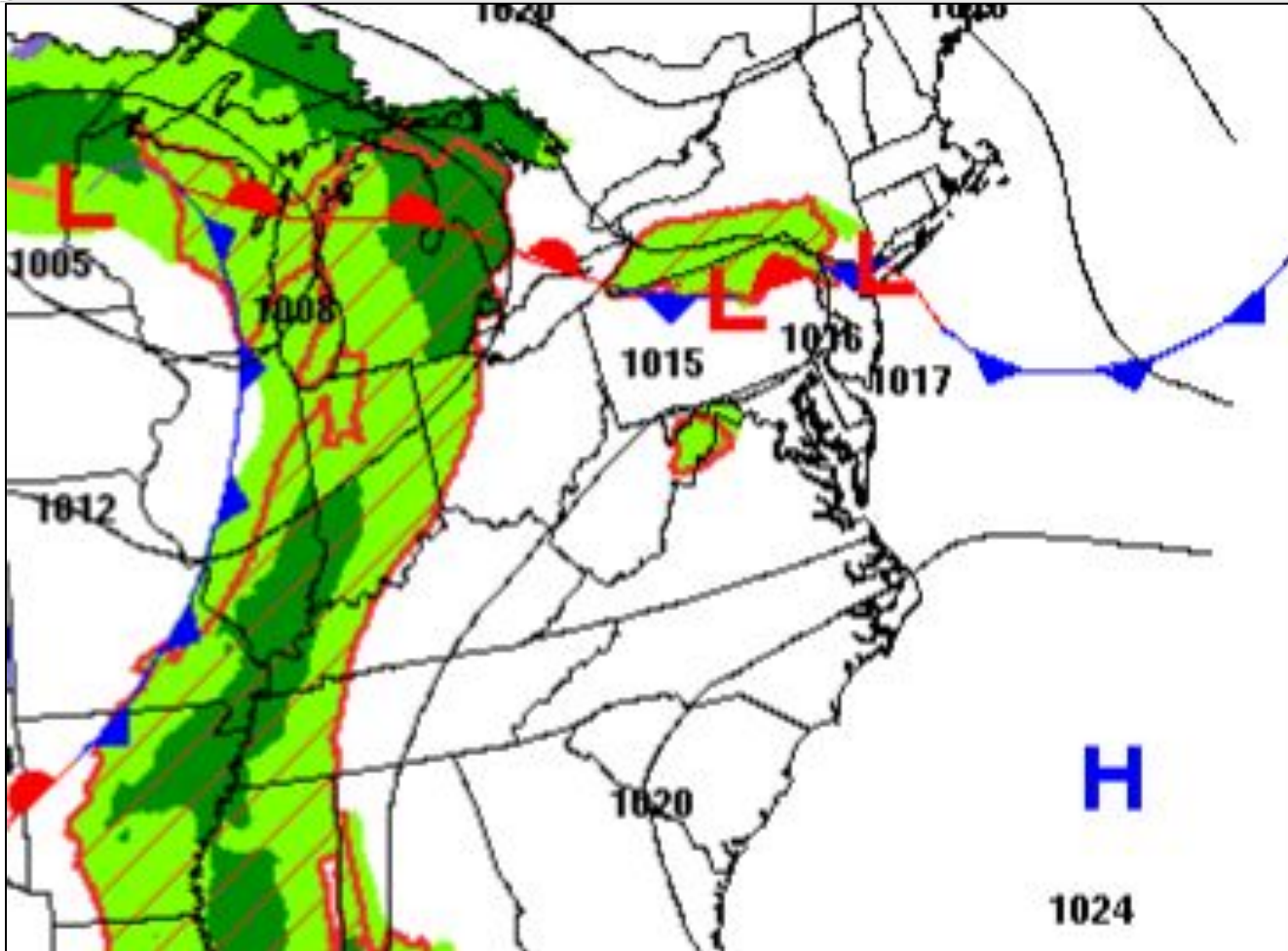




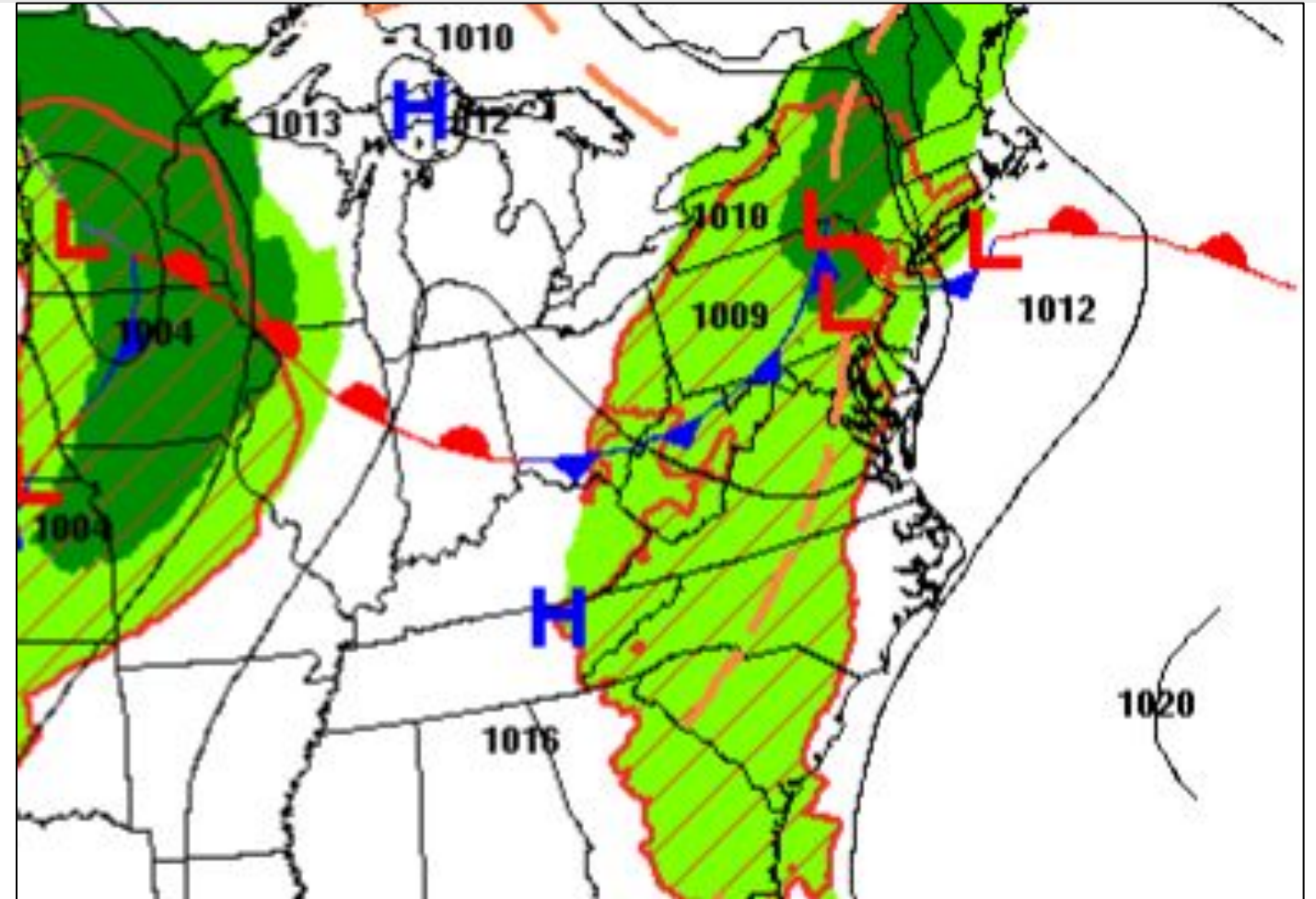
Thunderstorms Possible

Isolated Today, Better Chance Tuesday



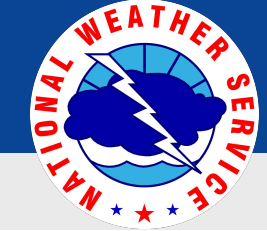
Map valid this afternoon and evening

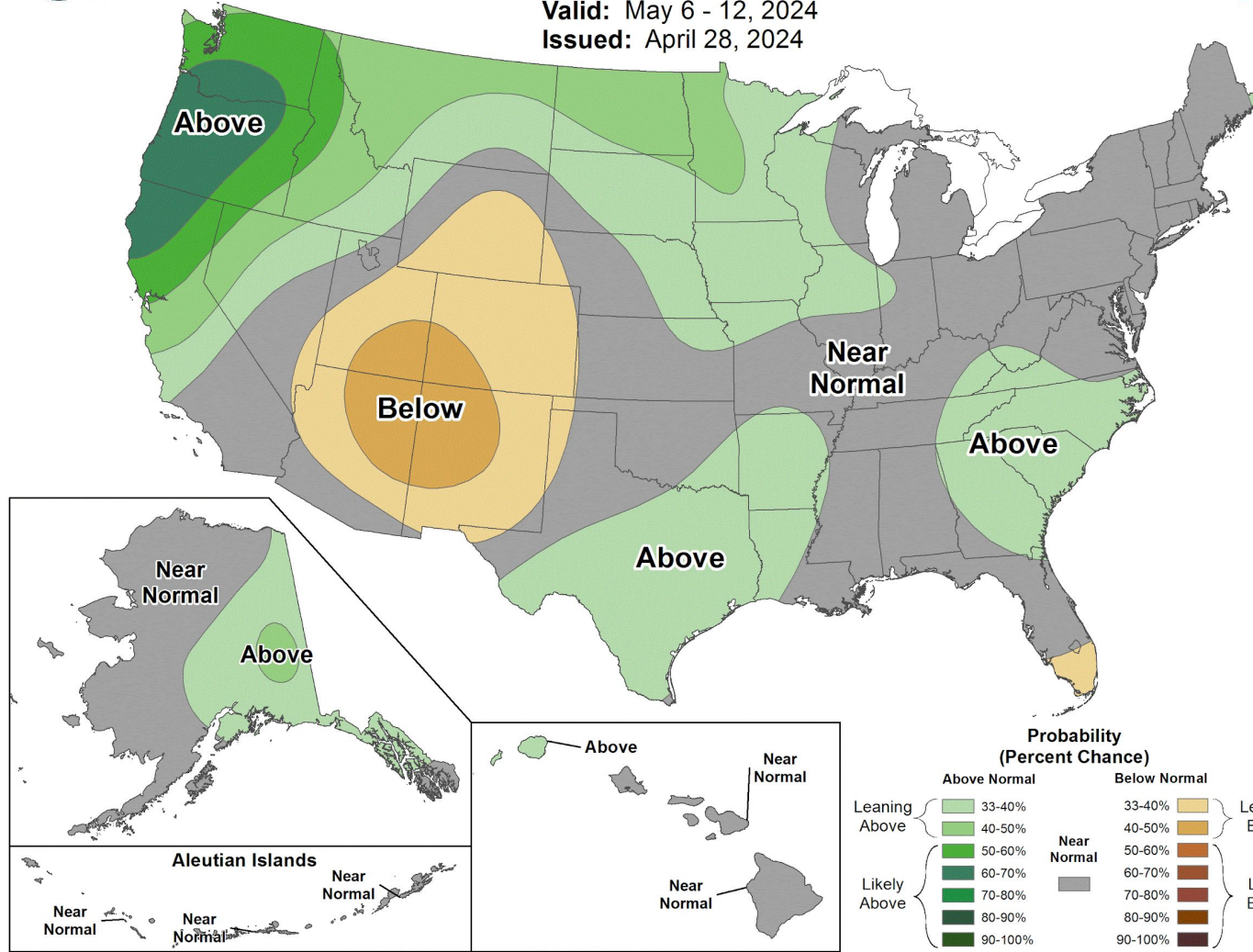

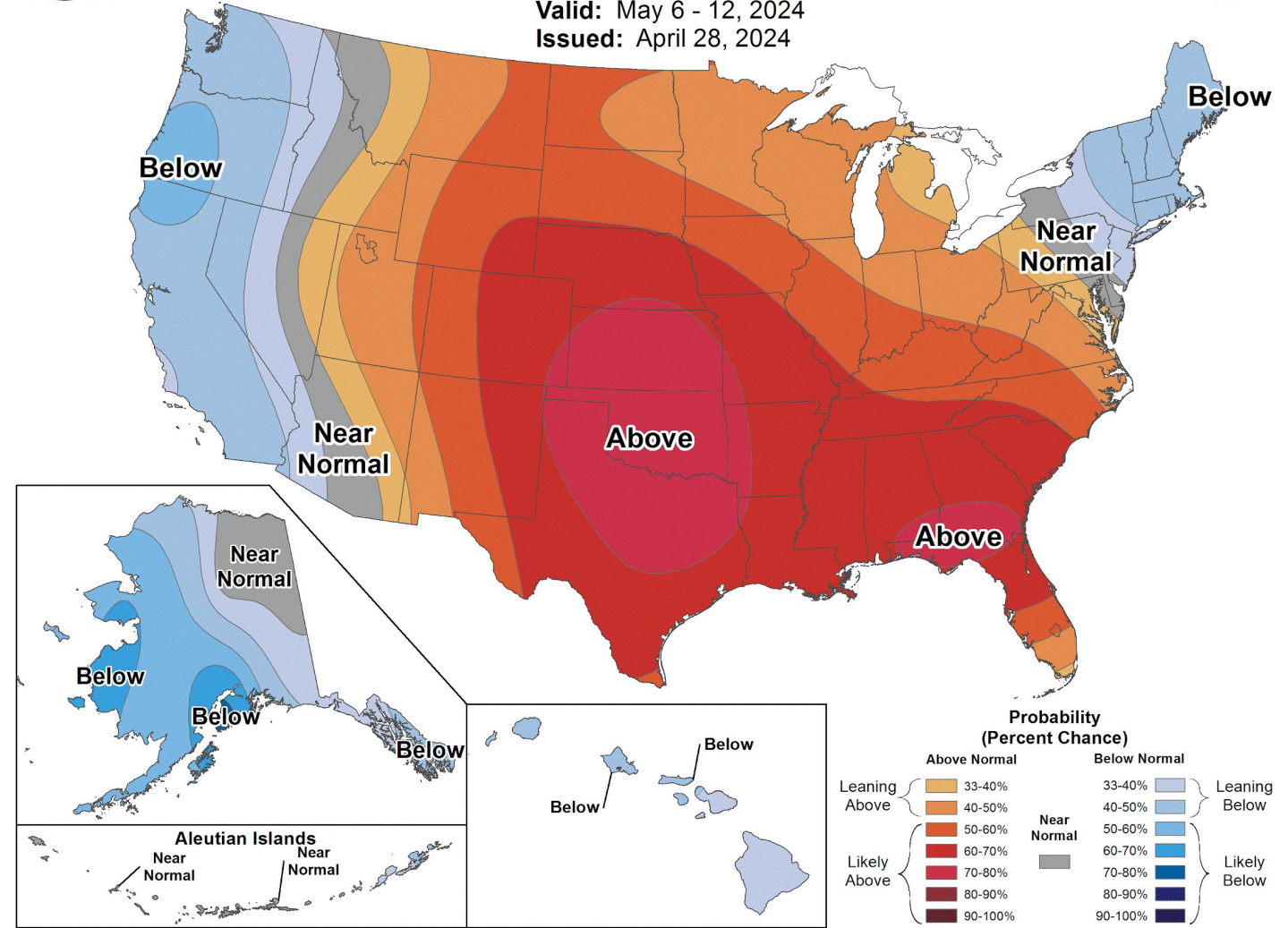
Near normal precipitation



8-14 Day Temperature Outlook

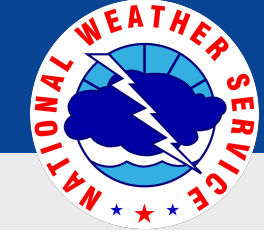

Near normal to leaning above normal temperatures



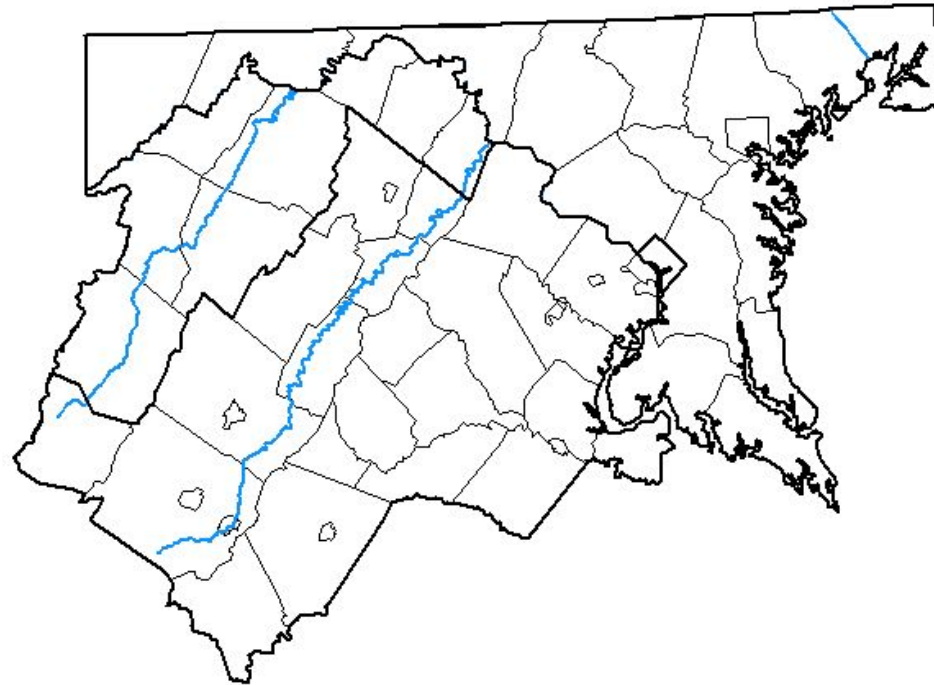
