The Cayman Islands National Weather Service is conforming to the WMO requirement that all Synoptic observations be transmitted in BUFR format. The two new BUFR formatted products are not currently on distribution to WMO RA-IV via GIFS or the GNC-A broadcast.

Observations at the main synoptic hours will be transmitted three times per day. Maximum file size will be approximately 500bytes and transmission will start on 5 January 2015
