Subject: Changes to Marine Weather Forecast Zones for WFO Tallahassee, FL: Effective March 18, 2025

Effective Tuesday, March 18, 2025, at 5:00 PM Eastern Daylight Time (EDT), 2100 Coordinated Universal Time (UTC), the NWS Weather Forecast Office (WFO) in Tallahassee, FL (TAE) will change Marine Forecast Zones encompassing the nearshore waters from Mexico Beach to the Walton-Okaloosa county line. The St. Andrews Bay system will be split into a separate marine zone. After this change, all forecasts and related products will use the zone numbers and names shown in Table 2 below.

If March 18, 2025 is declared a Critical Weather Day, this implementation will be postponed to Month 19, 2025 at 2100 UTC.

These changes will result in a more geographically precise forecast, improved watch and warning products for the general public and marine users and will enhance web-based graphical product consistency and appearance.

The current zone, GMZ750, will be split into two separate zones, GMZ735 (St. Andrews Bay Waterways) and GMZ751 (Coastal Waters from Okaloosa-Walton County line to Mexico Beach out 20 nautical miles). This split will optimize issuance of tropical and marine hazard products, as well as routine marine products. Conditions in the St. Andrews Bay system can vary significantly from areas over the open Gulf.
