ON FEBRUARY 19 2004...THE NATIONAL OCEANIC AND ATMOSPHERIC ADMINISTRATION
/NOAA/ SENT OUT A PUBLIC INFORMATION STATEMENT ANNOUNCING A PERIOD OF
PUBLIC COMMENT ON ADOPTING A POLICY REGARDING THE INFORMATION ACTIVITIES
OF THE NATIONAL WEATHER SERVICE /NWS/ AND POTENTIALLY OTHER NOAA
PROGRAMS. THIS NEW PROPOSED POLICY IS INTENDED TO STRENGTHEN THE
EXISTING PARTNERSHIP BETWEEN GOVERNMENT...ACADEMIA AND THE PRIVATE
SECTOR... WHICH PROVIDES THE NATION WITH HIGH QUALITY
WEATHER...WATER...CLIMATE AND RELATED ENVIRONMENTAL INFORMATION.

THE PERIOD DURING WHICH COMMENTS WILL BE ACCEPTED IS BEING EXTENDED UNTIL
JUNE 30 2004 TO ALLOW A MORE COMPLETE DIALOGUE ON THE PROPOSED POLICY.

THE PROPOSED POLICY RESPONDS TO RECOMMENDATIONS CONTAINED IN THE NATIONAL
RESEARCH COUNCIL/S /NRC/S / STUDY "FAIR WEATHER: EFFECTIVE PARTNERSHIPS
IN WEATHER AND CLIMATE SERVICES". THE NRC STUDY IDENTIFIED THE NEED FOR
A POLICY THAT WOULD RECOGNIZE ADVANCES IN TECHNOLOGY AND THE ENACTMENT OF
RELEVANT LAWS AND POLICIES...PARTICULARLY THE PAPERWORK REDUCTION ACT OF
1996...44 USC PART 45...AND OFFICE OF MANAGEMENT AND BUDGET /OMB/
CIRCULAR NO. A-130..."MANAGEMENT OF FEDERAL INFORMATION RESOURCES"...61
FR 6428 /FEBRUARY 20 1996...WHICH OCCURRED SUBSEQUENT TO THE PREVIOUS NWS
PARTNERSHIP POLICY ISSUED IN 1991.
