A COMBINED VALID TIME EVENT CODE /VTEC/ AND WATCH BY COUNTY /WBC/  
OPERATIONAL TEST AND EVALUATION /OTE/ IS SCHEDULED TO RUN FROM AUGUST 30  
2004 TO OCTOBER 15 2004. IN PREPARATION FOR THE OTE...ON AUGUST 26  
2004...MOST OFFICES PARTICIPATING IN THE OTE WILL TURN ON VTEC.

THIS MEANS OPERATIONAL AND TEST PRODUCTS CONTAINING EXPERIMENTAL VTEC  
STRINGS WILL BE ISSUED BY SELECTED NWS WEATHER FORECAST OFFICES /WFOS/ AND  
THE STORM PREDICTION CENTER /SPC/ STARTING AUGUST 26 2004. IN  
ADDITION...ALL OFFICES PARTICIPATING IN THE VTEC OTE WILL BEGIN USING A  
SEGMENTED FORMAT FOR FLOOD WATCHES /FFA/...FLOOD WARNINGS /FLW/ AND FLOOD  
STATEMENTS /FLS/ /THIS INCLUDES FLOOD ADVISORIES/. NOTE THAT FLASH FLOOD  
WARNINGS /FFW/ AND FOLLOWUP STATEMENTS /FFS/ WILL REMAIN UNCHANGED /NON-  
SEGMENTED/ THROUGH THE OTE.

NWS OFFICES LISTED IN TABLE 1 ARE SCHEDULED TO PARTICIPATE IN THE VTEC  
OTE. SOME OFFICES HAVE NOT YET VERIFIED READINESS TO BEGIN OTE  
PARTICIPATION AND WILL NOT BEGIN ISSUING APPROPRIATE PRODUCTS ON AUGUST 26  
2004...BUT WILL BEGIN ON OR AFTER SEPTEMBER 7 2004.

NWS OFFICES LISTED IN TABLE 2 ARE SCHEDULED TO PARTICIPATE IN THE WBC OTE  
AND EACH HAS VERIFIED READINESS TO BEGIN PARTICIPATION ON AUGUST 26 2004.
