OF NWS CLIMATE INFORMATION ON EXPERIMENTAL NWS CLIMATE WEBPAGES. ON
FRIDAY...SEPTEMBER 30 2005...AT 5 PM EDT /OR 2100 COORDINATED UNIVERSAL
TIME /UTC//... NWS CLIMATE INFORMATION...CURRENTLY AVAILABLE ON
EXPERIMENTAL NWS CLIMATE WEBPAGES...WILL BE REORGANIZED INTO A
STANDARD...UNIFORM METHOD OF DEPICTING EXISTING CLIMATE DATA. NO CHANGES
TO EXISTING PRODUCTS WILL BE MADE. THIS CHANGE TO EXISTING CLIMATE
INFORMATION IS SOLELY AN EFFORT TO HELP USERS MORE EASILY FIND CLIMATE
INFORMATION FROM SITE-TO-SITE. THE REORGANIZATION WILL TAKE PLACE AT ALL
LEVELS /NATIONAL...REGIONAL AND LOCAL WEATHER FORECAST OFFICE
/WFO//...WITH THE EXCEPTION OF CLIMATE INFORMATION PROVIDED BY THE CLIMATE
PREDICTION CENTER /CPC/. NO CHANGES ARE BEING MADE TO CPC WEBPAGES AT
THIS TIME.

CLIMATE WEB PAGES VIA A LINK ON THE LEAD CLIMATE PAGE OF EACH ENTRY LEVEL
/NATIONAL... REGIONAL AND WFO/. AS OF NOVEMBER 1 2005...THE EXPERIMENTAL
DESIGNATOR WILL BE REMOVED.
