EXISTING OPERATIONAL WATCH MESSAGES /I.E...SPECIAL WEATHER

STATEMENTS/ FROM EACH OFFICE WILL CONTINUE DURING THIS TEST PERIOD. THE TEST WATCH COUNTY NOTIFICATION MESSAGES WILL NOT BE PROVIDED IF BACKUP SUPPORT FROM ANOTHER NWS OFFICE IS REQUIRED DURING THIS TEST PERIOD.

THE WCN IS DESIGNED TO STREAMLINE WATCH INFORMATION FROM WEATHER FORECAST OFFICES...SO IT WILL BE USED TO CONVEY THE INITIAL ISSUANCE OF A CONVECTIVE WATCH...WHEN COUNTIES ARE BEING CLEARED FROM A WATCH...OR WHEN WATCHES ARE BEING CANCELED OR REPLACED BY NEW WATCHES.

THE WCN IS A SEGMENTED PRODUCT...WITH UNIQUE SEGMENTS FOR EACH ACTION TAKEN DURING A WATCH. SEGMENTS SHOWING COUNTIES IN A WATCH WILL BE SEPARATE FROM SEGMENTS DESCRIBING WHERE COUNTIES ARE BEING CLEARED FROM A WATCH.
