EFFECTIVE MONDAY...NOVEMBER 5 2001 AT 1900 COORDINATED UNIVERSAL TIME /UTC/...2 PM EST...TWO NEW FORECAST ZONES WILL BE CREATED IN CENTRAL AND DOWN EAST MAINE. PISCATAQUIS COUNTY WILL BE SPLIT INTO THREE PORTIONS...NORTHERN...CENTRAL AND SOUTHERN. AS A RESULT...ZONE MEZ010 /CURRENTLY SOUTHERN PISCATAQUIS/ WILL BE SPLIT INTO TWO PARTS...CENTRAL PISCATAQUIS /MEZ010/ AND SOUTHERN PISCATAQUIS /MEZ031/. THE NEW SOUTHERN PISCATAQUIS COUNTY ZONE WILL HAVE A BREAKPOINT LINE OF 45.12N/69.65W -45.51N/68.97W. ZONE MEZ004 /NORTHERN PISCATAQUIS/ WILL REMAIN UNCHANGED.

LIKEWISE...WASHINGTON COUNTY MAINE WILL BE SPLIT INTO THREE PORTIONS...NORTHERN...CENTRAL AND COASTAL. ZONE MEZ017 /CURRENTLY INTERIOR WASHINGTON/ WILL BE SPLIT INTO TWO PARTS...NORTHERN WASHINGTON /MEZ032/ AND CENTRAL WASHINGTON /MEZ017/. THE NEW NORTHERN WASHINGTON COUNTY ZONE WILL HAVE A BREAKPOINT LINE OF 45.27N/67.94W - 45.33N/67.45W. COASTAL WASHINGTON ZONE MEZ030 WILL REMAIN UNCHANGED.

THESE CHANGES WILL ALLOW FORECASTS FOR PISCATAQUIS AND WASHINGTON COUNTIES TO BE MORE AREA SPECIFIC...AND AFFECT THE PRODUCTS ISSUED BY NATIONAL WEATHER SERVICE WEATHER FORECAST OFFICE /WFO/ IN CARIBOU MAINE /CAR/ LISTED IN TABLE 2. THERE ARE NO CHANGES TO ANY COMMUNICATION IDENTIFIERS WITH THESE ZONE RECONFIGURATIONS AND NO ACTION IS REQUIRED FOR CONTINUED RECEIPT OF PRODUCTS FROM WFO CARIBOU.
