EFFECTIVE TUESDAY...NOVEMBER 20 2001...AT 4:00 AM CENTRAL STANDARD TIME
/0900 COORDINATED UNIVERSAL TIME/...THERE WILL BE A REALIGNMENT OF
FORECAST ZONE BOUNDARIES IN CHERRY COUNTY IN NORTH CENTRAL NEBRASKA.
CHERRY ZONE NEZ005 WILL BE DIVIDED INTO EASTERN CHERRY /NEZ005/ AND
WESTERN CHERRY /NEZ094/. THIS CHANGE AFFECTS PRODUCTS ISSUED BY THE NWS
WEATHER FORECAST OFFICE /WFO/ IN NORTH PLATTE NEBRASKA /LBF/.

THERE ARE NO CHANGES TO COMMUNICATION IDENTIFIERS WITH THIS REALIGNMENT
AND NO ACTION IS REQUIRED FOR CONTINUED RECEIPT OF PRODUCTS FROM WFO LBF.

APPROPRIATE ACTION SO YOUR SYSTEM/S/ RECOGNIZE THE NEW ZONE /Z/ UNIVERSAL

THESE CHANGES DO NOT AFFECT PRODUCTS USING THE COUNTY /C/ FORM OF UGC.
