ON JANUARY 7 2003...NATIONAL WEATHER SERVICE /NWS/ FORECAST OFFICES IN ALASKA WILL MODIFY THE COASTAL WATERS FORECAST /CWF/ PRODUCT TO PROVIDE GREATER DETAIL IN THE EXTENDED /3-5 DAY/ PORTION OF THE CWF. THIS IS A CUSTOMER-DRIVEN CHANGE THAT REPRESENTS THE FIRST STEP IN A SERIES OF IMPROVEMENTS THAT WILL BE MADE TO THE ALASKA MARINE FORECAST PRODUCT SUITE OVER THE NEXT TWO YEARS.

NOTE: THERE ARE NO CHANGES TO WORLD METEOROLOGICAL ORGANIZATION /WMO/HEADINGS OR ADVANCED WEATHER INTERACTIVE PROCESSING SYSTEM /AWIPS/IDENTIFIERS WITH THIS CHANGE AND NO ACTION IS REQUIRED FOR CONTINUED RECEIPT OF PRODUCTS FROM NWS FORECAST OFFICES IN ALASKA.
