OFFICE /WFO/ CENTRAL ILLINOIS WILL COMPLETE TRANSITION TO END-STATE WORLD
METEOROLOGICAL ORGANIZATION /WMO/ COMMUNICATION HEADERS FOR THEIR PUBLIC
PRODUCTS...SEE TABLE 1. THE SECOND LINE OF THE PRODUCT HEADER...KNOWN AS
THE ADVANCED WEATHER INTERACTIVE PROCESSING SYSTEM /AWIPS/
IDENTIFIER...WILL ALSO BE CHANGED TO REFLECT THE MODERN SITE LOCATION
IDENTIFIER. FOR EXAMPLE...SPI WILL BECOME ILX /CENTRAL ILLINOIS/.
