SUBJECT: MARINE ZONE COVERAGE CHANGE FOR NORTHEAST FLORIDA COASTAL AND INLAND WATERS: EFFECTIVE JULY 27 2004

EFFECTIVE TUESDAY JULY 27 2004...AT 1100 AM EASTERN DAYLIGHT TIME /EDT/...OR 1500 COORDINATED UNIVERSAL TIME /UTC/...MARINE ZONE FORECASTS ISSUED BY THE WEATHER FORECAST OFFICE /WFO/ IN JACKSONVILLE FLORIDA WILL BE IMPROVED TO ACCOUNT FOR GEOGRAPHIC AND CLIMATOLOGICAL FACTORS.

THE CHANGE CONSOLIDATES ALL FORECAST AND WARNING PRODUCTS FOR THE COASTAL WATERS OF NORTHEAST FLORIDA BETWEEN FERNANDINA BEACH FLORIDA AND ST. AUGUSTINE FLORIDA OUT TO 20 NAUTICAL MILES INTO THE MARINE ZONE AMZ452.

BECAUSE OF THESE CONSOLIDATIONS...USE OF AND REFERENCE TO MARINE ZONE AMZ435...PORT OF JACKSONVILLE...WILL BE DISCONTINUED. THIS CHANGE WILL SIMPLIFY THE NUMBER OF MARINE ZONES NEEDED TO EFFECTIVELY COVER THE FORECAST AREA AND ELIMINATE CONFUSION ASSOCIATED WITH THE GEOGRAPHICAL DEFINITION OF THE ZONE.

FORECASTS AND WARNINGS FOR THE INTRACOASTAL WATERWAY AND ST. JOHNS RIVER IN NORTHEAST FLORIDA WILL BE CONTAINED IN ROUTINE LAND BASED ZONE FORECAST AND WARNING PRODUCTS.

CUSTOMERS WILL NOT NEED TO MAKE ANY CHANGES TO CONTINUE TO RECEIVE THE CURRENT AMZ452. THIS IMPROVEMENT DOES NOT AFFECT PRODUCTS USING THE UNIVERSAL GEOGRAPHIC CODE /UGC/ COUNTY /C/ CODE.
