EFFECTIVE APRIL 28 AT 1200 COORDINATED UNIVERSAL TIME /UTC/...NWS WEATHER FORECAST OFFICES /WFOS/ IN ALBUQUERQUE NEW MEXICO /ABQ/...EL PASO TEXAS /EPZ/ AND MIDLAND TEXAS /MAF/ WILL IMPLEMENT CHANGES TO THEIR NEW MEXICO FIRE WEATHER ZONE BOUNDARIES...ZONE DESCRIPTOR NAMES...AND WILL ADD THREE /3/ NEW ZONE NUMBERS /NM113-115/.

WFO ALBUQUERQUE WILL HAVE RESPONSIBILITY FOR ZONES NM101-109. WFO EL PASO WILL HAVE RESPONSIBILITY FOR ZONES NM110-113. WFO MIDLAND WILL HAVE RESPONSIBILITY FOR ZONES NM114-115.
