THE TRADITIONAL SMALL CRAFT ADVISORY WILL CONTINUE TO BE ISSUED BY COASTAL WFOS IN THEIR COASTAL WATERS FORECAST /CWF/ AND BY GREAT LAKES WFOS IN THEIR NEARSHORE MARINE FORECAST /NSH/ WHENEVER WINDS AND/OR SEA/WAVE CONDITIONS ARE EXPECTED TO MEET OR EXCEED SPECIFIED THRESHOLDS. THESE THRESHOLDS VARY BY NWS REGION AND ARE USUALLY WINDS 20 KNOTS OR GREATER...AND/OR SEA/WAVES FIVE /5/ FEET OR HIGHER.

THE SMALL CRAFT ADVISORY FOR HAZARDOUS SEAS MAY BE ISSUED WHENEVER SEA OR WAVE CONDITIONS ARE EXPECTED TO SIGNIFICANTLY IMPACT SMALL CRAFT...AND WINDS ARE EXPECTED TO REMAIN BELOW THE SMALL CRAFT ADVISORY THRESHOLD. THIS THRESHOLD IS USUALLY LESS THAN 20 KNOTS.

- 3. EFFECTIVE TUESDAY...NOVEMBER 1 2005...AT 0000 UTC...THE SMALL CRAFT ADVISORY FOR WIND MAY BE ISSUED WHENEVER WINDS ARE EXPECTED TO MEET OR EXCEED SPECIFIED REGIONALLY DEFINED THRESHOLDS...AND SEA OR WAVE CONDITIONS REMAIN BELOW HEIGHT OR STEEPNESS THRESHOLDS.

THIS ADVISORY IS EXPECTED TO BE ISSUED MOSTLY BY THE WFOS IN THE PACIFIC NORTHWEST.

THE COASTAL WATERS FORECAST PRODUCT IS DISSEMINATED BY NWS COASTAL WFOS UNDER THE ADVANCED WEATHER INTERACTIVE PROCESSING SYSTEM /AWIPS/ PRODUCT IDENTIFIER /CWF/. THE NEARSHORE MARINE FORECAST PRODUCT IS DISSEMINATED BY NWS GREAT LAKES WFOS UNDER THE AWIPS PRODUCT IDENTIFIER /NSH/.

EXISTING CUSTOMERS WILL NOT NEED TO MAKE CHANGES TO THEIR AWIPS OR WORLD METEOROLOGICAL ORGANIZATION /WMO/ COMMUNICATIONS SYSTEM DIRECTORIES. HOWEVER...CUSTOMERS WHO RECEIVE OR PROVIDE SERVICES BASED ON THE PARSING OF EXACT TEXT STRINGS ARE ADVISED TO MAKE NOTE OF THIS CHANGE FOR THEIR SOFTWARE AND SYSTEMS OPERATIONS.
