SUBJECT: RECONFIGURATION OF SOME PUBLIC FORECAST ZONES ISSUED BY WFO PENDLETON OREGON: EFFECTIVE NOVEMBER 15 2005

EFFECTIVE TUESDAY...NOVEMBER 15 AT 2200 COORDINATED UNIVERSAL TIME /UTC/...200 PM PACIFIC STANDARD TIME /PST/...THE NATIONAL WEATHER SERVICE /NWS/ WEATHER FORECAST OFFICE /WFO/ IN PENDLETON OREGON /PDT/ WILL RECONFIGURE FOUR OF ITS PUBLIC FORECAST ZONES IN ITS AREA OF RESPONSIBILITY IN OREGON AND ONE ZONE IN WASHINGTON TO CREATE EIGHT NEW FORECAST ZONES. THE CURRENT ZONES ARE LISTED IN TABLE 1. THE EIGHT NEW WASHINGTON AND OREGON ZONES ARE LISTED IN TABLE 2.

NWS CUSTOMERS WILL NEED TO MAKE CHANGES TO PROPERLY RECEIVE WFO PENDLETON PUBLIC FORECAST AND WARNING PRODUCTS FOR THE RECONFIGURED ZONES.

THE CURRENT WASHINGTON ZONE 25 /EAST SLOPES OF THE SOUTHERN CASCADES/ WILL BE SPLIT AT 46.5 DEGREES NORTH LATITUDE FORMING TWO NEW EAST SLOPE ZONES /WASHINGTON 501 AND 502/.

THE CURRENT OREGON ZONE 46 /BLUE MOUNTAINS/ WILL BE SPLIT ALONG MCKAY CREEK WITH THE BORDER THEN RUNNING ROUGHLY PARALLEL BUT JUST SOUTH OF INTERSTATE 84 TO THE CURRENT OREGON ZONE 49 BORDER. THIS WILL CREATE TWO NEW BLUE MOUNTAINS OF OREGON ZONES /OREGON 502 AND 503/.

THE NORTHERN WHEELER/SOUTHERN GILLIAM COUNTIES ZONE /504/ WILL BE CREATED BY MERGING THE GILLIAM COUNTY PORTION OF THE CURRENT OREGON ZONE 45 /FOOTHILLS OF THE BLUE MOUNTAINS OF OREGON/ WITH THE WHEELER COUNTY PORTION OF THE CURRENT OREGON ZONE 47 /JOHN DAY BASIN/ NORTH OF THE JOHN DAY RIVER. THE REMAINING ZONES 45 AND 47 WILL RETAIN THEIR NAMES BUT THE ZONE NUMBERS WILL CHANGE TO 501 AND 505...RESPECTIVELY.

THE CURRENT OREGON ZONE 48 /OCHOCO-JOHN DAY HIGHLANDS/ WILL BE EXTENDED NORTHWARD IN WHEELER COUNTY TO THE JOHN DAY RIVER. THE ZONE NAME WILL REMAIN THE SAME BUT THE NUMBER WILL CHANGE TO 506.
