CORRECTED TO CHANGE ENDING DATE FOR IMPLEMENTATION OF NEW PRODUCT FORMATS FROM EARLY JUNE TO EARLY JULY...AND TO REMOVE REFERENCE TO NWS LOCATION IDENTIFIERS /NWSLI/ FROM THE HIGHLIGHTS OF NEW PRODUCT FORMATS. NWSLIS ARE PART OF THE HYDROLOGIC VALID TIME EVENT CODE /VTEC/ WHICH WILL BE IMPLEMENTED LATER.

FOLLOWING UP SERVICE CHANGE NOTICES /SCNS/ <u>04-56</u> AND <u>05-28</u>...THE PREVIOUSLY ANNOUNCED IMPROVEMENTS IN FORMATS FOR WEATHER FORECAST OFFICE /WFO/ HYDROLOGIC PRODUCTS WILL BE IMPLEMENTED OVER THE NEXT SEVERAL MONTHS...AS INDICATED BELOW...WHILE THE INCLUSION OF VTEC IN CERTAIN HYDROLOGIC PRODUCTS IS BEING DELAYED UNTIL LATER THIS YEAR.

THE NEW FORMATS ANNOUNCED IN SCN 04-56 AND 05-28 WILL BE IMPLEMENTED ON A WFO BY WFO BASIS STARTING IN EARLY FEBRUARY 2006 AND ENDING IN EARLY JULY 2006 FOR THE FOLLOWING PRODUCTS:

- 1. FLOOD WARNING FOR FORECAST POINTS /FLW/
- 2. FLOOD STATEMENT FOLLOW UP FLOOD WARNING FOR FORECAST POINTS /FLS/
- 3. AREAL FLOOD WARNING /FLW/
- 4. FLOOD STATEMENT FOLLOW UP AREAL FLOOD WARNING /FLS/
- 5. FLOOD STATEMENT AREAL ADVISORIES /FLS/
- 6. FLOOD ADVISORY FOR FORECAST POINTS /FLS/
- 7. FLOOD WATCH FOR FORECAST POINTS /FFA/

AS DESCRIBED IN THE PREVIOUS SCNS...THESE NEW FORMATS INVOLVE SEGMENTATION OF ALL SEVEN PRODUCTS LISTED ABOVE AND BULLETING OF ALL BUT PRODUCT NUMBER 4.

SOME HIGHLIGHTS OF THE NEW HYDROLOGIC PRODUCT FORMATS ARE AS FOLLOWS:

- FLOOD WARNINGS FOR FORECAST POINTS ON RIVERS AND STREAMS WILL BE BULLETED AND USE A ONE FORECAST POINT PER SEGMENT FORMAT...WITH EACH SEGMENT ENDING WITH A DOUBLE DOLLAR SIGN /\$\$/.

- EACH SEGMENT IN A FLOOD WARNING FOR FORECAST POINTS WILL HAVE ITS OWN UNIVERSAL GEOGRAPHIC CODE/S/ /UGC/S/ LISTED WITH THE ASSOCIATED FORECAST POINT. THIS MEANS THE SAME UGC COULD OCCUR IN MULTIPLE SEGMENTS IF A COUNTY HAS MORE THAN ONE FORECAST POINT.

- AREAL FLOOD WARNINGS AND ADVISORIES WILL USE A BULLETED...SEGMENTED FORMAT.

- THE START DATES FOR RISK REDUCTION ACTIVITIES AND OPERATIONAL TEST AND EVALUATION /OTE/ FOR VTEC ENCODED HYDROLOGIC PRODUCTS WILL BE ANNOUNCED IN SUBSEQUENT SCNS. AS STATED IN PREVIOUS SCNS...RISK REDUCTION ACTIVITIES AND OTE WILL INVOLVE INCLUDING VTEC IN ALL OF THE HYDROLOGIC PRODUCTS LISTED ABOVE...PLUS FLASH FLOOD WARNINGS /FFW/ AND FLASH FLOOD STATEMENTS /FFS/.
