SUBJECT: CHANGES TO THE BOUNDARIES OF SOME NORTHERN INTERIOR CALIFORNIA FIRE WEATHER ZONES: EFFECTIVE JUNE 1 2006

EFFECTIVE THURSDAY JUNE 1 2006 AT 1200 COORDINATED UNIVERSAL TIME /UTC/...NWS SACRAMENTO CALIFORNIA /STO/ WILL CHANGE SOME NORTHERN INTERIOR CALIFORNIA FIRE WEATHER ZONE BOUNDARIES AND ZONE DESCRIPTOR NAMES.

THE PURPOSE OF THE CHANGE IS TO SUPPORT A MORE EFFICIENT FORECAST PROCESS AND PROVIDE NWS FIRE WEATHER CUSTOMERS WITH IMPROVED WATCH...WARNING AND FORECAST PRODUCTS. HISTORICALLY...THE WEST SLOPES OF THE CENTRAL SIERRA NEVADA MOUNTAINS OF NORTHERN INTERIOR CALIFORNIA HAVE BEEN REPRESENTED BY ONE /1/ LARGE FIRE WEATHER ZONE /CAZ269/. THIS HAS RESULTED IN BROAD AND GENERIC FORECASTS. THE CHANGE BEING IMPLEMENTED WILL DIVIDE THIS LARGE ZONE INTO TWO ZONES MORE CLOSELY ALIGNED WITH FIRE AGENCY DISPATCH BOUNDARIES AND CLIMATIC REGIMES.

ONCE THIS CHANGE HAS BEEN IMPLEMENTED...THE FOLLOWING ZONE NAMES AND GEOGRAPHICAL DESCRIPTORS WILL BE USED IN ALL FIRE WEATHER FORECAST PRODUCTS ISSUED FOR NORTHERN INTERIOR CALIFORNIA:

INCLUDES ALL OF THE LAND FROM THE STANISLAUS NATIONAL FOREST WEST OF THE SIERRA CREST...BORDERED ON THE NORTH BY THE ELDORADO NF AND BORDERED ON THE SOUTH BY YOSEMITE NATIONAL PARK.
