CORRECTED FOR TYPO IN TABLE 5...SHORT TERM FORECAST: ORIGINAL WAS KPHI...CORRECTED TO KAKQ. NO OTHER CORRECTIONS.

EFFECTIVE WEDNESDAY JULY 15 2009 AT 200 PM EASTERN DAYLIGHT TIME /EDT/ OR 1800 COORDINATED UNIVERSAL TIME /UTC/...THE NWS BALTIMORE/WASHINGTON WEATHER FORECAST OFFICE /WFO/ WILL RECONFIGURE ITS MARINE ZONES FOR PORTIONS OF THE MARYLAND CHESAPEAKE BAY AND TIDAL POTOMAC RIVER.

CURRENTLY...THERE ARE EIGHT MARINE ZONES COVERING THE MARYLAND CHESAPEAKE BAY AND TIDAL POTOMAC RIVER. MOST OF THE SMALL RIVERS AND TRIBUTARIES CURRENTLY ATTACHED TO THESE MARINE ZONES WILL BE REMOVED AND MERGED INTO PUBLIC WEATHER ZONES. SIX NEW MARINE ZONES WILL THEN BE CREATED COVERING THE SMALL RIVERS AND TRIBUTARIES THAT CUSTOMER FEEDBACK HAS IDENTIFIED AS CONTAINING HIGH BOAT TRAFFIC. RECONFIGURATION WILL IMPROVE MARINE WARNINGS...FORECASTS AND SERVICES BY ALLOWING THEM TO BE MORE AREA SPECIFIC.

MARINE ZONE WITH UNIVERSAL GEOGRAPHIC CODE /UGC/ DESIGNATOR OF ANZ535...NAMED KEY BRIDGE TO INDIAN HEAD...WILL REMAIN UNCHANGED.

MARINE ZONES WITH UGC DESIGNATORS OF ANZ536...NAMED INDIAN HEAD TO COBB ISLAND...AND ANZ537...NAMED COBB ISLAND TO SMITH POINT...COVER THE MIDDLE TO LOWER PORTION OF THE TIDAL POTOMAC RIVER.

EFFECTIVE JULY 15 2009...SMALL RIVERS AND TRIBUTARIES WILL BE REMOVED FROM ANZ536 AND ANZ537 AND MERGED WITH PUBLIC WEATHER ZONES. THE FOLLOWING PUBLIC WEATHER ZONES FROM THE BALTIMORE/WASHINGTON FORECAST OFFICE WILL BE AFFECTED:
