EFFECTIVE TUESDAY...MAY 18 1999 AT 11:00 A.M. CENTRAL DAYLIGHT TIME...1500  
COORDINATED UNIVERSAL TIME /UTC/...THE NATIONAL WEATHER SERVICE WILL  
TRANSFER WARNING RESPONSIBILITY FOR LOWER MONROE COUNTY /I.E. THE KEYS/  
AND SURROUNDING COASTAL WATERS /TABLE 1/ TO THE WEATHER SERVICE OFFICE  
/NWSO/ IN KEY WEST FLORIDA /EYW/ FROM THE WEATHER SERVICE FORECAST OFFICE  
IN MIAMI FLORIDA /MIA/. THIS TRANSFER WILL INCLUDE SHORT-FUSED PUBLIC AND  
MARINE RESPONSIBILITIES.

TRANSFERRING SHORT-FUSED SERVICES FROM MIA TO EYW IS THE FIRST STAGE OF  
PLANNED SERVICE TRANSFER FOR A NEW OFFICE TO SERVE RESIDENTS ON THE  
FLORIDA KEYS.

FOR LOWER MONROE COUNTY...NWSO EYW WILL ISSUE SHORT-FUSED WARNINGS /TABLE  
2/...OTHER RELATED PRODUCTS THAT GIVE FOLLOW-UP INFORMATION CONCERNING  
WATCHES AND WARNINGS /TABLE 3/...OTHER MISCELLANEOUS PRODUCTS /TABLE  
3/...AND SHORT-FUSED MARINE PRODUCTS /TABLE 4/.
