TODAY... WEDNESDAY...AUGUST 11 1999 AT A WHITE HOUSE PRESS CONFERENCE...DEPARTMENT OF COMMERCE SECRETARY WILLIAM M. DALEY AND NATIONAL WEATHER SERVICE /NWS/ DIRECTOR JACK KELLY WILL ANNOUNCE THREE NEW NWS PRODUCTS DESIGNED TO PROVIDE THE PUBLIC INFORMATION ON SIGNIFICANT WEATHER...WATER AND CLIMATE EVENTS. THE THREE PRODUCTS ARE THE NATIONAL WEATHER SERVICES THREATS ASSESSMENT...THE NATIONAL WEATHER SERVICE/S AND DEPARTMENT OF AGRICULTURE/S JOINT U.S. DROUGHT MONITOR PRODUCT...AND THE NATIONAL WEATHER SERVICE/S HEAT INDEX FORECAST PRODUCT.

BECOMING OPERATIONAL TODAY...THE THREATS ASSESSMENT PRODUCT IS A FORECAST OF POTENTIAL SIGNIFICANT WEATHER ACTIVITY OVER THE NEXT THREE TO TEN DAYS. THIS FORECAST FOR EXTREME CONDITIONS SUCH AS TEMPERATURE...PRECIPITATION...WIND AND DROUGHT...IS UPDATED WEEKLY OR MORE FREQUENTLY AS EVENTS REQUIRE. THE THREATS ASSESSMENT PRODUCT PROVIDES WEATHER-SENSITIVE USERS SUCH AS EMERGENCY MANAGERS...LOCAL OFFICIALS...FORECASTERS AND THE PUBLIC ADVANCE NOTICE OF ONGOING AND FUTURE WEATHER...WATER AND CLIMATE EVENTS. ARMED WITH THIS INFORMATION...COMMUNITIES AND INDIVIDUALS CAN TAKE PRECAUTIONARY STEPS AND PUT PLANS IN PLACE TO MITIGATE THE IMPACTS OF POTENTIAL EXTREME EVENTS.

THE U.S. DROUGHT MONITOR PRODUCT SUMMARIZES THE EXTENT AND INTENSITY OF DROUGHT NATIONWIDE AND FORECASTS WHETHER DROUGHTS WILL STRENGTHEN OR WEAKEN IN THE NEXT TWO WEEKS. THE MAP USES A NEW CLASSIFICATION SYSTEM TO SHOW DROUGHT INTENSITY AND TYPE...SIMILAR TO THOSE FOR HURRICANES AND TORNADOES. THE MAP COMBINES KEY INDICES OF RAINFALL AND DROUGHT TO PRODUCE THE FINAL DROUGHT INTENSITY RATING. SINCE DROUGHT OFTEN AFFECTS VARIOUS ACTIVITIES DIFFERENTLY...THE MAP INDICATES IF DROUGHT IS AFFECTING AGRICULTURE...FIRE DANGER OR WATER SUPPLIES. THIS PRODUCT IS STILL EXPERIMENTAL AND IS EXPECTED TO BECOME OPERATIONAL BY EARLY SEPTEMBER.

WE WILL WORK TO GET THE THREATS ASSESSMENT AND THE DROUGHT MONITOR ON THE EMERGENCY MANAGER/S WEATHER INFORMATION NETWORK /EMWIN/ AND NOAAPORT AS SOON AS POSSIBLE.

THE TWO-WEEK HEAT INDEX FORECAST PRODUCT WILL BECOME AVAILABLE NEXT SUMMER. TODAY...THE NWS USES A HEAT INDEX TO GIVE AN ACCURATE MEASURE OF HOW HOT IT REALLY FEELS WHEN RELATIVE HUMIDITY IS ADDED TO THE ACTUAL AIR TEMPERATURE. NEXT SUMMER...NWS WILL FORECAST THESE EXTREME HEAT EVENTS UP TO TWO WEEKS IN ADVANCE. FOR THE FIRST TIME...THESE FORECASTS WILL PROVIDE LOCAL NWS OFFICES AS WELL AS HEALTH OFFICIALS AND LOCAL DECISION MAKERS WITH A "HEADS UP" FOR POTENTIALLY LIFE THREATENING CONDITIONS THAT FAR IN ADVANCE. LOCAL FORECAST OFFICES WILL THEN WORK WITH LOCAL HEALTH OFFICIALS AND LOCAL DECISION MAKERS TO HIGHLIGHT THE IMPACTS TO THE LOCAL AREA.
