NOTE: THE FOLLOWING CHANGES HAVE NO IMPACT ON NOAA WEATHER WIRE SUBSCRIBERS.

ONE YEAR AGO...THE NATIONAL CENTERS FOR ENVIRONMENTAL PREDICTION /NCEP/ BEGAN AN EFFORT TO RENAME AND CONSOLIDATE THE MEDIUM RANGE FORECAST /MRF/ AND AVAITION /AVN/ MODEL RUNS INTO A SINGLE SYSTEM CALLED THE GLOBAL FORECAST SYSTEM /GFS/. THE MRF RUN WAS DISCONTINUED IN APRIL 2002 AND FORECAST DATA FROM THE 0000 COORDINATED UNIVERSAL TIME /UTC/ AVN HAS BEEN DISTRIBUTED IN ITS PLACE EVER SINCE.

THE NEXT STEP IN THIS PROCESS WILL OCCUR ON TUESDAY...APRIL 15 2003...WHEN THE NCEP MODEL GRAPHICS WEBPAGE WILL BE UPDATED TO REFLECT THIS NEW CONFIGURATION. ON THIS DATE...THE MRF GRAPHICS AND WEBPAGES WILL BE REMOVED AND THE AVN WEBPAGES AND GRAPHICS WILL BE RENAMED THE GFS. USERS WHO ACCESS THESE IMAGES WITH A WEB BROWSER WILL NOT BE GREATLY IMPACTED BY THIS CHANGE. USERS WHO ACCESS THESE IMAGES DIRECTLY...WITHOUT A WEB BROWSER...WILL HAVE TO MODIFY THEIR SCRIPTS TO POINT TO THE RENAMED DIRECTORIES AND IMAGES.
