SUBJECT: REMOVAL OF 1000 AND 1500 FOOT FORECASTS FOR THE LANAI AIRPORT  
/LNY/FROM THE HAWAII LOW LEVEL 6-...12- AND 24-HOUR UPPER WINDS AND  
TEMPERATURES ALOFT FORECAST BULLETINS

EFFECTIVE TUESDAY...SEPTEMBER 27 2005 AT 1200 COORDINATED UNIVERSAL TIME  
/UTC/...THE 1000 AND 1500 FOOT FORECASTS FOR THE LANAI AIRPORT /LNY/ WILL  
BE REMOVED FROM THE HAWAII LOW LEVEL 6-...12- AND 24-HOUR UPPER WINDS AND  
TEMPERATURES ALOFT FORECAST BULLETINS. AS THE ELEVATION OF THE LANAI  
AIRPORT IS 1308 FEET ABOVE MEAN SEA LEVEL /MSL/...THE 1000 AND 1500 FOOT  
FORECASTS WERE ERRONEOUSLY INCLUDED IN THE LOW LEVEL FORECAST BULLETINS.  
NWS WILL RETAIN THE REMAINING FORECASTS FOR THE LANAI AIRPORT BETWEEN 2000  
AND 53000 FEET.
