TIME /UTC/...THE CLIMATE REFERENCE NETWORK /CRN/ WILL INTRODUCE A NEW
DAILY01 PRODUCT. THE ADVANCED WEATHER INTERACTIVE PROCESSING SYSTEM
/AWIPS/ IDENTIFIER FOR THE DAILY01 PRODUCT WILL BE CRND01.

THE DAILY01 PRODUCT CONTAINS OBSERVATIONS OF PRECIPITATION...AIR
TEMPERATURE...SOLAR RADIATION AND SURFACE AIR TEMPERATURE. THE DATA IS
SUMMED OR AVERAGED OVER DAILY PERIODS FOR ALL AVAILABLE CRN STATIONS.
