EFFECTIVE 1400 COORDINATED UNIVERSAL TIME /UTC/ ON TUESDAY DECEMBER 7 2010...THE CODING OF THE SPC FIRE WEATHER OUTLOOK PRODUCTS ISSUED IN GRIDDED BINARY VERSION TWO /GRIB2/ FORMAT WILL CHANGE. SPC ONLY ISSUES GRIB2 FIRE WEATHER OUTLOOK PRODUCTS FOR CONTIGUOUS U.S. /CONUS/ LOCATIONS.

IF DECEMBER 7 2010 IS DECLARED A CRITICAL WEATHER DAY...THIS IMPLEMENTATION MAY BE DELAYED. PARTNERS AND USERS WILL BE NOTIFIED VIA AN UPDATED TECHNICAL IMPLEMENTATION NOTICE AS SOON AS POSSIBLE AND A NEW IMPLEMENTATION DATE WILL BE ANNOUNCED.
