The Chair called for approval of the minutes. The minutes were approved by acclamation of the voting members.

- 4. NTHMP Coordinating Committee membership vacancies
 - CNMI Emergency Management representative

Gerald Guerrero, present for the meeting, will serve as the official Alternate for Emergency Management for the CNMI. Jonathan Villagomez will remain the primary voting emergency management member.

Guam and CNMI Science Representative after Chip Guard retires

The decision for recommendation on this position is pending. An update will be provided at the next Coordinating Committee meeting in September.

- 5. Status updates from NTHMP entities
 - a. Mapping & Modeling Subcommittee

Allan reported on behalf of the MMS: The MMS is moving forward with activities on its Annual Work Plan. Most items will be completed by early 2020.

An update report was review and is appended to these notes for reference.

Arcas: is there a schedule for Powell Center reports?

Ross: the first report is completed. Others are in process for completion by volunteers.

b. Mitigation & Education Subcommittee

Miller reported on behalf of the MES:

- We are looking for feedback on the maritime website under development.
- We had an update on Tsunamizone.org. Work is progressing on additional web pages for Hawaii, Alaska, and Washington.
- The MES was briefed on the social science project by Washington State. A report is forthcoming.
- Guidance has been developed for maritime mitigation.
- Future mitigation topics will be for for ASCE building codes and vertical evacuation.
- We received an update on the National Disaster Preparedness Training Center (NDPTC) Tsunami course (AWR-217).

- The MES had a good discussion about TsunamiReady. Thanks to the WCMs who were able to join us.
- We had reports on vertical evacuation best practices for Washington and Oregon.
- We had a discussion on exercises, including target dates for CaribeWave, PacWave, LanTex

Allan: are there any high level results from the social science project?

Dixon: Washington state inner coast community revealed that most of the outreach has been done for the outer coast, so inner coast residents don't realize that a tsunami may take 2 – 3 hours to reach them. Most thought it was 20-30 minutes.

More evaluation of the results is needed to write the report in layman's terms.

The results showed that some people still believe in the incorrect "triangle of life" and getting into a doorway during an earthquake. Much more corrective education is required.

Arcas: we're getting a lot of guestions on ASCE 7-16.

Allan: why we created the M&R Work Group (see later in these minutes)

Arcas: would be valuable to have a multistate approach.

Wilson: The M&R Work Group is a multi-state group. Please let me know about questions you are getting so I can provide feedback to ASCE.

c. Mitigation & Recovery Work Group

Wilson: This group had a meeting recently where we developed a list of internal and external mitigation products. We have developed a draft hazard assessments table.

We are asking how to engage TsunamiReady better – can maritime communities become recognized as TsunamiReady?

Lopes: Government or quasi-Government entities can be recognized as TsunamiReady. A maritime community should be recognized as a whole, not the maritime portion only because tsunamis affect people on the land, too.

Wilson: We were inspired by the Oregon debris workshop. We are developing a guidance document on debris estimates.

We are developing two harbor inspection forms and guidance: 1) A quick before arrival inspection, and 2) immediate post-tsunami inspection.

d. Warning Coordination Subcommittee

McReery reported on behalf of the WCS:

- Everyone attended the WCS meeting on Tuesday. We introduced Dr. James Gridley, the Director of the National Tsunami Warning Center. We re-engaged the WCS and reconstituted our activities.
- Each TWC updated on their respective activities.
- We had a discussion of TWC backup capabilities.
- We are looking at seamless backups of each other's Center.
- We discussed Information Decision Support Services (IDSS) from the TWCs to partners, including SIFT output two-pagers on forecast for tsunamis.
- Discussed tsunami.gov. The site is working and probably will not be changed significantly until more human resources are available.
- Confirmed that WCS will have quarterly phone conference call meetings.

Arcas: are the two-page IDSS products to be made available to the public or Emergency Managers only?

Gridley: the target is emergency managers, but may be available to the public.

Forson: once it hits our state email, it is considered public by Washington state law.

Dixon: We would use it to inform local emergency managers.

Wilson: be careful on release of the map part of the product.

Allan: agreed – don't want a product going out that could confuse the public, especially about a distant event.

Rizzo: doing that could introduce uncertainty, especially regarding evacuations.

Huerfano: Puerto Rico has tsunami 3 focal points who would receive them.

Miller: once we get it, we distribute it to 20 Emergency Managers on the coast, and what they do with it is up to them.

Dixon: we don't want these maps getting out that could undermine the work we have done with public education.

Gridley: we look forward to your help to us to address these issues.

Rizzo: a disclaimer line on the two-pagers may help.

Von Hillebrandt: when we see products developed at one TWC, those served by the other ask why they can't get them too. We need to be mindful of this at the NTHMP level.

Gridley: SIFT will be applied identically at each TWC.

McCreery: PTWC hasn't been involved, but would like to cooperate and assist.

e. Island Caucus

Lewis: we decided that we would like to continue as a Caucus. Will create a mission and vision statement and will develop Goals & Objectives. We will share items from other subcommittees for review for island interests.

f. Gap Analysis Work Group

Allan: The gap analysis spreadsheet was circulated to Work Group members. We are trying to organize it for higher-level information for proposals & metrics. There are subtabs for warning, outreach, mapping & modeling. It is now being reviewed by other subcommittee leaders to request their input.

Forson: each state needs to look at alerting gaps and work with respective TWCs. Wondering if we want to include this checkbox in the gap analysis.

Wilson: gap analysis should include where SIMs are run and forecast points.

6. NTHMP Subcommittee and Projects Accountability

Lopes: Annual Work Plans with ties to the *NTHMP 2018-2023 Strategic Plan* have been requested from each Subcommittee since 2018. AWPs were requested so that the Strategic Plan would remain evergreen and not have to be changed as accomplishments occurred.

Lopes noted that there were some concerns that subcommittee meetings have changed to have a more business-like approach and some people have noted that the information exchange process for states may be more formal now.

Lopes asked, "now that this AWP process has been in place for two years, how is it working?"

Wilson: The MMS has a lot of tasks, but the process is working well.

Miller: The AWP format is helpful and gives structure. The process is working for the MES.

Cooper: This process links our national strategies to local needs.

Forson: Would feedback/success stories from locals help?

Cooper: That would be good for the NTHMP Annual Report.

Allan: That would be a great idea and could be helpful for advocacy efforts.

Angove: We are interested in how the U.S. is prepared for tsunamis. These reports provide specifics on how we're doing that.

Lopes asked how ongoing updates to subcommittee AWPs should be shown besides reading the meeting notes from iterative meetings.

After discussion, the subcommittee Co-Chairs agreed that they would provide updated soft copy of respective AWPs for posting on NTHMP website after each meeting.

Von Hillebrandt: Should planning for subcommittee meeting items be on the AWP?

Lopes: Yes.

7. Outcomes of Discussion on NTHMP Structure from Thursday afternoon

Note: most of this discussion was held on Thursday, August 22. No detailed notes were taken at that meeting, but the following motions resulted from these discussions:

a. Mitigation and Recovery Planning Work Group

Motion: (made by Wilson, seconded by Allan): Establish a **Mitigation & Recovery Planning Work Group**. The Work Group will develop its *Terms of Reference*(identifying leadership, terms of leadership service, membership, and how accountability will be reported to the Coordinating Committee) to submit to the Coordinating Committee for approval.

Discussion: none

Vote: motion approved by unanimous consent of the voting members.

The Chair called for nominations for initial leadership. Previous discussion indicated one emergency manager and one scientist.

Forson suggested that there be a Federal Agency leader as well. Lopes said that would be fine, as long as NWS Headquarters was not expected to offer meeting travel support.

The following people were nominated or were volunteered: Rick Wilson of California, Maximilian Dixon of Washington, and Amanda Siok of FEMA Region X.

b. Subcommittee review of tasks on AWPs:

The Chair asked each Subcommittee to consider which, if any, of the tasks on their current AWP may be reassigned to another NTHMP entity, reprioritized, or kept, in coordination with initial leadership of Mitigation & Recovery Work Group for tasks that could/should be taken on by them.

c. Island Caucus

The Chair requested written goals and objectives and *Terms of Reference* (identifying leadership, terms of leadership service, membership, and how accountability will be reported to the Coordinating Committee) from the Island Caucus. Lopes will provide a template for Terms of Reference.

d. Change of MES Terms of Reference

Motion (made by Biasco, seconded by von Hillebrandt): Change MES *Terms of Reference* by changing current 3 Co-Chair positions as follows:

Instead of equal Co-Chairs, there be a Chair, First Vice Chair, and Second Vice Chair, each with one-year terms.

During the NTHMP Annual Meeting each year, the Subcommittee will nominate one person for the Second Vice Chair position by vote of all Subcommittee members present at the meeting in person or by phone (Proxies are not allowed). At the next Coordinating Committee following this nomination, the current MES Chair will request confirmation of this election. The term for the person elected is three years.

On conclusion of the NTHMP Annual Meeting each year, the person serving as First Vice Chair becomes the Chair. The person serving as Second Vice Chair becomes the First Vice Chair. The person serving as Chair rotates off the leadership team and returns to regular membership status, but is eligible for nomination to serve again as Second Vice Chair.

One of the MES leadership positions will be from a Federal agency, and two will be from states. The NWS will make every effort to provide travel support as available for the Federal Agency MES leadership person to travel to the NTHMP Annual and Winter Meetings.

This change will take effect at the 2020 NTHMP Annual Meeting.

e. Other discussion

Belanger: The "M" of MES also the same word for the "M" in the Mitigation & Recovery Work Group.

Mahoney: there is a difference between mitigation that doesn't involve bricks & mortar versus mitigation that does (FEMA BRIC), so that's the difference between the M's of each group.

von Hillebrandt: can we have a discussion on when the subcommittee leadership positions are elected? At the winter meeting or the summer meeting?

Cooper: when should we have these elections?

Motion (made by Biasco, seconded by Miller): keep elections at the Annual meeting, now held in the summer.

After discussion, by unanimous consent, the current Co-Chairs of all NTHMP subcommittees will continue to serve in their current positions until the 2020 NTHMP Annual Meeting.

8. Non-structural updates to NTHMP Rules of Procedure

a. <u>Move Annual Meeting to Summer on a permanent basis</u>

NTHMP Annual Meeting now will be in the summer (July or August). This will include time for meetings of all NTHMP subcommittees and other entities as needed; partners updates; and a Coordinating Committee meeting.

Motion made by Belanger / seconded by von Hillebrandt

Discussion: Huerfano – summer is a busy time.

Lopes: scheduling of meetings has a lot to do with availability of meeting space and hotel rooms. We try for late July, but each meeting is different.

The Chair called for a vote: this motion was approved by unanimous consent.

b. Winter Subcommittee Meetings; Program Review

NTHMP Winter Meeting (January or February) will be a meeting of the MES, MMS, Island Caucus, Mitigation & Recovery Work Group, and also include a simultaneous formal Program Review with the sponsoring Federal Agency regarding grant activities and plans.

Motion made by Ross, seconded by Belanger

Discussion: Is this permanent?

Cooper: we will be doing program reviews regardless.

Angove: we will be doing this concurrently with subcommittee meetings – need to evaluate how this goes.

The Chair called for a vote: this motion was approved by unanimous consent.

c. <u>Clarification on travel support from NWS Headquarters</u>

The process of handling travel to NTHMP meetings relying on grant-funded partners to use grant funds to support it is a permanent situation. The NWS HQ will not be in a position to offer invitational travel to all NTHMP CC members who are traveling to NTHMP Meetings. As such, the following change to the language in the RoP should be made:

To the extent that funds are available, National Weather Service Headquarters travel support for individuals to attend NTHMP winter or annual meetings may be offered to: 1) Federal Government employees who are CC members and who are unable to have travel funded by grants; and 2) Co-Chairs (or Chairs/vice chairs) of NTHMP Subcommittees (but not Caucus or Work Groups) if not a member of the Coordinating Committee.

If funding must be prioritized by meeting type, the Annual Meeting is of higher priority than the Winter Meeting.

Travel for individuals may be further prioritized by NWS HQ if required to meet funding limitations and will be determined at the time decisions may be required.

NWS Headquarters travel support is not offered to: 1) guest speakers or SMEs at NTHMP meetings or workshops; 2) regular members of Subcommittees, Caucus(es), or Work Groups, 3) workshop attendees, or 4) Federal Contractors.

Motion made by Biasco, seconded by Lewis

Discussion: none

The Chair called for a vote: this motion was approved unanimously

d. Clarification of Quorum Count

Presence of the NOAA Chairperson is counted toward quorum count for Federal agency representation on the NTHMP Coordinating Committee.

Motion made by Mahoney, seconded by von Hillebrandt

Discussion: Lopes explained that we just had to confirm that for purposes of quorum, that we count the Chair, even though the Chair doesn't vote unless there is a tie.

The Chair called for a vote: this motion was approved by unanimous consent.

9. Work Group to update NTHMP Rules of Procedure and Subcommittee Terms of Reference

The Chair appointed a Work Group to work on revisions to the *Rules of Procedure*. The updated *Rules of Procedure* will be provided to the Coordinating Committee to read in advance before a vote to adopt them.

The following people volunteered to serve on this short-term Work Group: Biasco, Wilson, and von Hillebrandt.

The Chair appointed them, with Lopes to lead the group.

10. Old Business

The NTHMP Winter Meeting will be in Portland, Oregon, tentatively January 27 – 31, 2020, upon confirmation that adequate hotel rooms are available.

11. New Business

Lopes: should we do a review of the 2018-2023 NTHMP Strategic Plan?

Cooper: we should do this as a part of the program review from each subcommittee as well as each state & territory.

Other new business:

Wilson: we talked about the possibility of combining meetings with other conferences. It might be beneficial if the NTHMP held a session at the AGU Conference, held informally such as at lunch time. Kelly will look into it with AGU. This could be called an "NTHMP Stakeholders" session.

12. Adjourn

Chair Grant Cooper welcomed Dr. James Gridley, the newly appointed Director of the National Tsunami Warning Center. James gave a brief self-introduction.

Dr. Cooper also welcomed Ms. Denise Lewis, the Acting Director of the Virgin Islands Territorial Emergency Management Agency. Denise is the likely USVI emergency management appointee to the NTHMP Coordinating Committee.

Dr. Cooper called for approval of the minutes. The minutes were approved by acclamation.

4. NTHMP meeting in summer in light of change to winter meeting in San Diego

Considering that the government shutdown of December 22, 2018, to January 25, 2019, caused travel for all Federal employees to be canceled, we were unable to have an official "annual meeting." Similar thing happened last year.

Lopes proposed to move the 2019 NTHMP Annual Meeting to the summer and include all three subcommittees, Island Caucus, as well as discussion about NTHMP Governance and thoughts about grant projects for the FY20 grant round.

Richards: I agree with that. Concerned that we have done all this work for the annual meeting and have a shutdown interfere with these plans. I want to take the time to do this right and move the meeting to a time less susceptible to be affected by a government shutdown. The NTHMP is well worth the effort to do this.

Angove: We are willing to recast the meeting into the summer. I like the idea for having this meeting in the summer for the reasons described, including grants discussion to ensure proposals fit the national plan.

Eblé: I agree that the summer is safer. Is four days enough?

Lopes: We're talking about 4.5 days if we include a meeting of the Coordinating Committee.

Eblé: What does this mean about having two meetings?

Belanger: We are not taking away from having two meetings, but flip-flop them. Have the MES and MMS subcommittees meet in the winter, and the full complement of the annual meeting with all subcommittees in the summer.

Eblé: Is this going to be a permanent change?

Group: (collectively) – yes.

Lopes: technically, this is a one-time change until the NTHMP *Rules of Procedure* are updated. Currently the RoPs state that the Annual Meeting is held in January or February.

Rizzo: We need to set dates asap.

Eblé: And where will we meet?

Lopes: Considering that only 3 days of funding has been placed on grants that cover travel during summer 2019, we have to select a meeting location that has a very low hotel and M&IE per diem rate so the nightly hotel and per diem costs can be paid from existing funds. With that in mind, we are considering Salt Lake City, which has an FY19 hotel per diem rate of \$125/night and \$56 M&IE rate.

Cooper: The NWS Western Region would welcome the NTHMP back.

Lopes: What should we consider for alternate locations in case Salt Lake City doesn't work out?

Wilson: Sacramento is a possibility including meeting at the USC Price School where we met in summer 2018.

Stroker: The NCEI facility in Asheville, NC, could be a possibility.

Lopes: FY19 per diem rates – Sacramento: \$135/\$66; Asheville: \$122 / \$56 (though California state employees are prohibited from traveling to North Carolina.)

We also did an informal poll yesterday and the week of July 22 was suggested as the first choice week.

Von Hillebrandt: There is a big science meeting in Toronto the week before July 22.

Miller: A HAZUS for Earthquake and Tsunami course will be held at FEMA's Emergency Management Institute the week of July 22, and that may cause a conflict for some of us.

Lopes: The week of July 29th was also discussed.

Rizzo: [motion] I move that we have a full "NTHMP Annual Meeting" as described in the summer with first choice the week of July 29 and in Salt Lake City. Victor Huerfano seconded the motion.

No discussion. The Chair called for a vote: motion passed unanimously.

Lopes: I will work with these choices and dates and get back to the Coordinating Committee when details are known regarding availability and not conflicting with an already planned National Warning Coordination Meteorologists meeting to be held this summer.

5. Proposals from partners for hosting of 2020 Annual Meeting and Summer Meetings

Allan: We offer Portland, Oregon, for the winter meeting.

Wilson: Sacramento is possible for the summer meeting if not selected for 2019.

Richards: Finding different places to go is great.

Forson: What about meeting in Seattle?

Lopes: per diem rates for the summer make Seattle too costly (\$257/night + 20% taxes), however, the rates are lower in Lynnwood (Snohomish County) north of Seattle. We've met there before at the FEMA Region 10 building.

Biasco: access to the FEMA facility is difficult and there could be some members who could not get permission to enter. So meeting at FEMA Region 10 is out.

Arcas: Olympia could be an option.

Lopes: Travel logistics between the Seattle airport and Olympia are challenging. However, thanks for the input. I will prepare cost workouts and discuss options with the Chair to select the most viable and affordable option.

6. Confirm frequency and schedule of NTHMP CC meetings for 2019 between now and the next Annual Meeting.

Proposed meeting dates: 2nd or 3rd Tuesday of odd-numbered months at 3pm Eastern Time. These dates are clear on the Chair's calendar: March 12; May 21; July 16; September 17; November 12.

Richards: [motion] I move that we accept these dates for meetings of the Coordinating Committee. Nicholas seconded.

No discussion. The Chair called for a vote: motion passed unanimously.

7. Reconfirmation of appointment of NTHMP Chair, Grant Cooper

The NTHMP Rules of Procedure require reconfirmation of a two-year term of the Chair.

Nicholas: [motion] I move to reconfirm the two-year term of Grant Cooper to serve as Chair of the NTHMP. Richards seconded.

No discussion. The Chair called for a vote: motion passed unanimously.

8. Updates from each NTHMP Subcommittee and confirmation of Co-Chair votes as necessary

a. Mapping & Modeling Subcommittee

Grilli: [motion] I move that the state Co-Chair position be approved for the MMS recommendation of Jon Allan of Oregon. Nicolas seconded.

No discussion. The Chair called for a vote: motion passed unanimously.

Eblé: Recognized all of the work that Dmitry Nicolsky has put in over the four years he served as MMS Co-Chair. Lopes stated that he provided public recognition for Dr. Nicolsky at this week's meeting in San Diego.

b. Mitigation & Education Subcommittee

Lopes: the state Co-Chair and NOAA Co-Chair terms have ended and a nomination for someone for each position was needed. The MES did not vote on this matter during its business meeting this week.

Miller: I am willing to serve another two-year term as MES state Co-chair.

von Hillebrandt: I am willing to serve another two-year term as the MES NOAA Co-Chair.

Richards: [motion] I move that the state Co-Chair position be approved for Kevin Miller and the NOAA Co-Chair position be approved for Christa von Hillebrandt. Nicholas seconded.

No discussion. The Chair called for a vote: motion passed unanimously.

c. Island Caucus

Lopes: explained that last year, terms of Island Caucus Co-Chairs were changed to become staggered. Victor Huerfano took a one-year term. Kevin Richards took a two-year term. So now the Co-Chair position that Victor Huerfano had is up for election.

Richards: thanked Victor Huerfano for serving three years as the Island Caucus Co-Chair.

Richards: [motion] I move that the Island Caucus Co-Chair position as nominated by the Island Caucus be approved for Denise Lewis of the U.S. Virgin Islands. Brown seconded.

No discussion. The Chair called for a vote: motion passed unanimously.

d. Warning Coordination Subcommittee

Lopes: there are three Co-Chairs for this subcommittee. One is from the PTWC, one is from the NTWC, and one is from a state. Currently, Dan Belanger completed a term as state Co-Chair that he filled last year when Althea Rizzo stepped down. Belanger indicated that he was willing to serve another two-year term.

Richards: [motion] I move that the state Co-Chair position for the WCS be approved for Dan Belanger. Nicholas seconded.

No discussion. The Chair called for a vote: motion passed unanimously.

9. [DISCUSSION] NTHMP Subcommittee Annual Work Plans

The MMS and MES briefly presented about their Annual Work Plans as discussed during respective business meeting this week.

a. Mapping & Modeling Subcommittee

Wilson: source database formalized, include metadata, find a place for it to reside. This is an iterative process through 2020; CA taking the lead on it. Second task – continuation of development of maritime guidance with MES support. Led by CalOES & California Geological Survey. Make it user friendly, consider developing a website to support it and have it be linked-based. Try to come up with strategies for different end-users such as USCG, harbors & ports, and the cruise industry. Ongoing task in FY19 at \$13K co-proposal between CalOES & CGS.

Miller: This was also endorsed by the MES.

Wilson: There are other items as well that you can see on the MMS Annual Work Plan.

b. Mitigation & Education Subcommittee

The MES developed a draft that needs input from other Co-chairs who were not in San Diego this week. Projects include social science project completion and evaluation of results. Looking at other social science topics; maritime safety project with the MMS; gap analysis spreadsheet; vertical evacuation guidance; HAZUS; exercise scenario modeling. Need to discuss with the subcommittee before finalization and approval.

Endorsed these state-requested projects:

Oregon: project on community cache development.

Rizzo: this is a project to produce a guidance document to put together emergency supply caches for communities.

American Samoa: large scale exercises in observation of 2009 tsunami – travel for exercise observers for 2019 tsunami exercise.

c. Note: since the WCS did not meet in San Diego, there will not be an Annual Work Plan for this subcommittee

Lopes: The Warning Coordination Subcommittee will need to meet to review the 2018 WCS work plan and create a new one for 2019.

10. [DISCUSSION] NTHMP Subcommittee Structure and Workload Analysis

Lopes: following a vote during the July 25, 2018, Coordinating Committee meeting, a Work Group was appointed by the Chair to write a discussion paper about the structure of the NTHMP subcommittees and workload. That paper was completed and shared with the members of the Coordinating Committee on December 20, 2018. Further, recommendations from the members of the Work Group were developed for consideration by the NTHMP Coordinating Committee. Those recommendations were also sent to the Committee members on December 20 (and again on January 28.)

Cooper: thanked the members of the work group for their work. This begins a conversation.

Miller: The paper looks at strengths and weaknesses of subcommittee structure and steps through the issues. Ends with questions for the CC to spur conversation.

Note: a robust discussion followed for about an hour. Lopes noted that detailed notes of these thoughts would not be recorded. Only actions would be recorded in these minutes.

No motions or changes to any NTHMP Governance documents were made as a result of this discussion.

The follow-up actions are:

- Lopes will ask all members of the Coordinating Committee to read the recommendations provided, and edit them or add any new recommendations they may have.
- Upon return and consolidation of these recommendations, Lopes will ask the members of the Coordinating Committee to review, rank, and prioritize any recommendations that may require specific actions.
- Those follow-up actions may include: appointment of a short-term Work Group by the Chair; revisions to subcommittee *Terms of Reference*; and/or revisions to the *NTHMP Rules of Procedure*.

11. Old Business

There was no old business.

12. New Business

Allan: from a meeting on Tuesday, we discussed a gap analysis regarding the status of where partners are regarding tsunami preparation. We reviewed different versions of a spreadsheet that documents elements of individual state and territory tsunami preparations status. I request the Chair form a work group to evaluate the gap analysis to identify elements to be captured in it and report back to the Coordinating Committee.

Allan: [motion] I move that the Chair form a Work Group to evaluate gap analysis needs for NTHMP partners. Nicolsky seconded.

Discussion:

Miller: Is this work group under the MES or MMS?

Lopes: Neither. The Work Group is independent.

Richards: I have some questions about how the gap analysis would be maintained. I'll share them with the Work Group.

Volunteers: the following people volunteered to serve on this Work Group: Kevin Richards, Jon Allan, Dmitry Nicolsky, Chip Guard, Maximilian Dixon, Yvette LaDuke, and Denise Lewis.

There was no more discussion. The Chair called for a vote. The motion was approved unanimously and the Chair made these appointments. Jon Allan will coordinate activities of this Work Group and Rocky Lopes will offer support and follow up as necessary.

13. Adjourn

There was no more business. The meeting was adjourned by the Chair at 10:52am PST.
