The Federal Review Panel is in the process of reviewing all of the pre-applications. We're a little behind our self-imposed deadline, but well ahead of NOAA Grants Management deadlines.

The Federal Review Panel may have questions, please make every effort to respond as quickly as possible.

The plan is to have that review done by the end of this week and we'll brief Dr. Cooper shortly thereafter.

From there, we make a recommendation to NWS Leadership.

5. [DISCUSSION] No Cost Extensions - NTHMP Administrator

We recognize these are challenging times. We have a total of 34 open grants right now. We cannot sustain this pace. We ask that you do everything possible to close out all previous year's grants by 31 August 2021 - as continued No Cost Extensions are not guaranteed. We also would like to limit No Cost extensions for FY20 grants - however, if you feel like you will be requesting them, please let us know your intent by April 30. All Award Action Requests must be approved by the NWS Tsunami Program Office in GrantsOnLine by July 30th. All states/territories should have their Award Action Requests in GrantsOnLine by June 15. Lewis and I will need time to review the requests prior to making the request in GrantsOnLine. Please have all requests to me and Lewis by May 14.

Yvette LaDuke: Any discussion of lengthening the grant cycle to two years like what was done before?

A: That was tried a couple years ago, and it did not work out well, so we went back to the 1-year cycle.

### 6. [DISCUSSION] FY21 in-person meetings. NTHMP Administrator

There will be no in-person NTHMP meetings for FY21.

We are looking to host the Winter meetings in Sacramento - we are still working on the details.

Yvette LaDuke: most hotels are booked, therefore maybe the meeting should be delayed or held in another location. Grant: AMS is in January. Christa: other meetings are in the second and third week of Feb.

Ian Sears: need to work around all other meetings like Primo. Yvette: could try other cities if in early Jan.

Stephanie Ross: Powell center is Jan 10-14.

Yvette LaDuke: Sacramento may work well in the summer. Jon: maybe SLC for summer meeting? Grant Cooper: It can be expensive with limited Gov Rates. Jon will look into Portland for the winter meeting. AK in winter? It's possible. Crescent City is also possible.

### 7. [DISCUSSION] - NWS Decision on HazSimp - NTHMP Administrator

The NWS will be implementing changes to its hazard messaging headlines no earlier than calendar year 2024. This decision is based on results of extensive social science research with partners and the public, which documented significant confusion with current NWS headline terms. This research indicated that NWS' "Advisory" headlines are responsible for a major portion of the confusion. This is because the Advisory term itself is misunderstood and its meaning is often conflated with that of "Watch." Such confusion can lead to a misunderstanding of forecast severity and certainty with respect to significant weather and water hazards. This, in turn, can adversely impact user preparation for (and response to) these hazards. The major changes are as follows: - All "Advisory" headlines within what is currently the NWS Watch, Warning and Advisory system will be discontinued. Most of the current Advisory headlines will be replaced with plain language headlines that clearly articulate the nature of the hazard. However, these messages will still be equipped with computer-readable Valid Time Event Code (VTEC) as they are today. - Exceptions to the transition to plain language will apply to Tsunami and Small Craft Advisories. These Advisories will be elevated to the Warning level due to the life-threatening conditions associated with these hazards. The exact title of the Warning for what is now a Tsunami Advisory is to be determined.

The NWS Tsunami Program will work closely with the WCS/ITIC/CTWP/NTWC/PTWC/NWS Regions to determine the title of the Warning and the Language used.

I will be leading the effort for the NWS Tsunami Program. My goal is to get it right and I will be engaged in the process.

I do not yet know what the process will look like, but once I do, I will be sure to keep you all informed.

Althea Rizzo: will take time for states and territories to educate the public, which will take time. Need to start working with locals sooner than later. Grant: agrees that we need to get the education process started. Maximilian: lots of things will need to be changed, and it will be helpful to have as much info as possible early on. Tsunami is one of two products that will be changed to warnings, possible more lead time, but will need to stay ahead of the effort.

Yvette LaDuke: Will put together a survey to gather input from NTHMP. Chat will be saved from this meeting for ideas.

For our **maritime mitigation and recovery guidance task**, we feel we have completed our work here, contributing what we thought was relevant to the Maritime Guidance website put together by CA. Having said that, as new products and guidance is

developed, we will submit updates on mitigation and recovery to Todd Becker at Cal OES to include in the website.

We also have a task to develop guidance on the uses of probabilistic tsunami hazard analysis information and how best to communicate PTHA to various user groups. Corina Allen led a task work group meeting at the end of last month where group planning and expected outcomes were discussed. The group was briefed on some of the uses of PTHA, discussed who the potential user groups would be, and started developing strategies for developing the guidance.

There was also some progress on our third task: to help with development of guidance for addressing tsunami debris issues. MRPWG group members participated in a multi-state meeting led by Althea Rizzo with the guidance for local agencies to develop tsunami debris plans or tsunami sections that can be added to existing debris plans. Althea is looking to bring in a consultant or possibly someone through a university to help with developing this guidance. We also are assisting with the MMS-supported effort to hold a tsunami debris modeling and product workshop; CA has started the process of contracting with Pat Lynett at USC who is working with Dan Cox of Oregon State to lead this workshop and develop a report and findings which will be integrated into the guidance being developed by Oregon.

Lastly, we also have a task to develop guidance for lead officials to find funding to help with tsunami mitigation and recovery efforts. We will be holding a task work group meeting next Monday to discuss potential available funding sources for tsunami mitigation and recovery planning work, and scoping out plans for developing the guidance.
