1. Update of Action items from 3/1

Action 3/1 - Review RUHT for possible enhancements (Reed) – There will be some changes in the message handling in OB6 and we will review the capabilities after OB6 has been installed at most of the offices.

2. Development Update -

2a. Retrieval of Ratings (Pokorny) – The alpha version of program was delivered to LMRFC last week and they have installed it. LMRFC made their first run to test the software yesterday and all worked well.

The alpha version met all of the requirements except notification service when a rating curve changes and some minor configuration issues must be worked out. Dan expects to have a full version ready for testing next week. There are 3 or 4 offices that have agreed to test the procedures and Dan will work with them one at a time to address and correct any issues.

2b. Graphical User Interface to process ratings (Pokorny) – Some work has been completed on the architecture and coding will start in late June or early July after NCRFC installs OB6.

2c. Post ratings from GUI to NWSRFS (Alcorn) – To get ratings into NWSRFS, CBRFC prepares the FCINIT input cards for defining a rating. She will coordinate with Dan on these procedures when he starts coding the GUI.

2d. Utilities (Roberts and Jolly) – LMRFC plans on meeting next week to discuss the utilities and plan for development.

3. Project Plan (Reed) – An updated draft of the project plan was provided to the team. They are to provide comments by the end of May.
