- OSIP Project RFC Archive Server Technology Refresh Initiative

 - Project in OSIP Stage 3
 - Archiving survey to be filled out by each RFC by ~08/01/2008 on non-hardware needs
 - By the end of OSIP Stage 3:
 - final technical archiving requirements
 - business case
 - implementation plan



Archiving Requirements: Status

- Current archiving requirements: 10-911 Directive
- HEP group report, "Data archiving requirements for forecasting and verification purposes"
 - includes archiving survey results from NWS Verification Team
 - requirements to support CHPS/FEWS and XEFS
 - for single-valued and probabilistic forecasting, hindcasting and verification
- Other OSIP projects working on archiving system:
 - CHPS Infrastructure project
 - RFC AWIPS Configuration project
 - AWIPS Extended project




Archiving Requirements: Status

- Tasks to be performed
 - Importing/storing data and metadata
 - Display/quality control of archived data
 - Exporting archived data
 - Model(s) calibration
 - Forecaster training, case studies
 - Development activities
 - Hindcasting (re-forecasting)
 - Display and statistical analysis of input and output data
 - Real-time forecast verification
 - Forecast verification with the National Baseline Verification System (NBVS)
 - Generation of user specified products
 - Others?



Data Archiving Requirements

Data for Experimental Ensemble Forecast System (XEFS)



Data Archiving Requirements: High Priorities

- Observations w/ metadata (6/24-hr or less)
 - MAP, MAT, other forcing inputs, flow, stage
- Forecasts w/ metadata (6/24-hr or less)
 - FMAP, FMAT, other forcing inputs
 - PQPF, PQTF, other forcing inputs
 - flow or stage: raw and MOD-ed forecasts, simulations
 - Flow or stage probabilistic/statistical forecasts
- Rating curves and other model parameters
- Initial conditions: raw and operational
- Verification info to run IVP and EVS
- Metadata for all archived data: date, time, location, time step, scale, grid resolution, units, how data/product was generated



Archiving System: Next Steps?

- Get form-fit-function upgrades and assess impact on system performance
- Continue to document deficiencies of current system
 - Provide feedback to RFC Archive Team
- Find ways to archive high priority data for verification
 - Observations for all forcing inputs, flow, stage
 - Deterministic forecasts for all forcing inputs and flow/stage (w/ MODs)
 - Rating curves (past and current)
 - Metadata
